

# SiCAP LTC Results (KII's)

## LTC challenges:

- implementation issues,
- financial issues,
- lack of political and stakeholder support,
- OP and familial issues, and
- lack of knowledge on LTC;

*“Sorry, I’m not ano [against] the LGUs, but for me, It is the problem that we’re facing with the non-readiness of the health workers. And lalo na, Geriatric Care kasi ang pinag uusapan.”*

### Quotes re agency in charge of LTC

*"I think it's the Department of Health. I think it's really important that the DOH is really on top of, and would be in-charge for the long-term care program in the country. To ensure that mas ano siya, ah... because the DSWD will only come in to talk about the vulnerable sectors. But talking about long-term care, it's not just about the socio-economic, but the poor who need our help. It talks about the universe of the senior citizens who should have an option, once they feel na hindi na safe ang kanilang environment for themselves." - KII003*

*"For that po, we would recommend na ang in-charge po for this one po is National Commission for Senior Citizens, kasi they have the mandate. The Republic Act 11350, kung saan nakalagay na sila yung, uhm, parnag oversight, titingin ng implementation ng program regarding senior Citizens. Actually, doon rin po nakalagay na eventually, from DSWD, i-turn over to the National Commission or NCSC, yung mga kanilang funds."*

# SiCAP LTC Results (FGDs)

OPs have expressed their **willingness** to utilize LTC and **preferred LTC arrangements**

Identified factors:

- capability to spend/budget
- health condition of OP
- family's caring capacity
- situation of the family in general

**Topics that the carers would like to learn related to LTC:**

- Caregiving skills
- Understanding and handling of OPs
- Physical activities
- Health protocols
- Self-care and medical management, and
- First aid treatment

No National LTC  
policy

No specific agency  
in charge for long-  
term care in the  
country.

LTC services are  
available in the  
country and are  
delivered through:

- Most are focused on the establishment of local facilities.

- Government-run residential care facilities
- Private nursing homes, residential facilities, and home care providers.

## **SiCAP LTC Conclusion**

- ❖ Major challenge: Lack of knowledge and political and stakeholder support
  - Consistent with the findings of other studies conducted in the US<sup>6</sup>, Thailand<sup>7</sup>, and other countries in the Asia Pacific.<sup>8</sup>

# SiCAP LTC Project Cost-Effectiveness Analysis

- Two scenarios:

Domiciliary and Home Care service only versus  
Full long-term care service.

Markov model with an annual cycle lasting 20 years involving  
a population of individuals 60 years old and above

Willingness-to-Pay (WTP) threshold helps determine if an  
intervention is cost-effective and guides decision-makers in  
allocating resources

# Results

Healthcare facility	Baseline average annual cost per patient (PHP)	ICER baseline	WTP (PHP)	Average annual cost threshold per patient (PHP)	
Nursing Home	984,918	929,088	697,990	736,810	Need to be 25% lower
Assisted-Living Facility	504,918	929,088	697,990	423,696	Need to be 16% lower



# HLTC Objectives

- **General objective:** To comprehensively describe the long-term care needs of older adults, while also assessing the influence of their current health environment and the availability of healthcare mechanisms and services tailored to their unique requirements.
- **Specific objectives:**
  - 1. To analyze the stakeholders of the home and long-term care
  - 2. To understand the concept of inclusive and community based home and long term care guidelines aligned with the strengthening of primary care services.
  - 3. To develop recommendations for person-centered health and long-term care planning that address the specific service delivery needs, requirements, and preference of older persons and their communities.
  - 4. To propose strategies for strengthening community -based support systems and services to cater to the diverse needs of older adults and their caregivers.

- 149 older people and their carers
